The following categories are used to identify monies which do apply toward your church's commitment to the overall work of Presbytery, Synod, and General Assembly:

- A. **UNIFIED MISSION GIVING (BUDGETED)** - for the Mission Programs of the General Assembly, Synod, and Presbytery. All monies will be distributed according to the approved budget for the current year as adopted by the Presbytery. Identify designated causes and amounts, if any, within this category.
- B. **SPECIAL (OVER-AND-ABOVE) GIFTS/OFFERINGS/COMMITMENTS** - for mission giving commitments which **do not** apply toward your church's basic commitment through the Presbytery, as reported in sections A and D.
- C. **OTHER DESIGNATED GIVING (NOT INCLUDED IN UNIFIED GIVING)** - for monies given beyond the Budget adopted by the Presbytery but committed to selected causes. Identify each selected cause.
- D. **PER CAPITA** - for the Per Capita Apportionment.
